**Transaction in Own Shares**

Vertu Motors plc (AIM: VTU) announces that on 6 September 2017, it purchased 87,750 ordinary shares of 10p each in the Company on the London Stock Exchange (the “Repurchased Shares”), pursuant to the share buyback programme (the “Buyback Programme”) announced on 26 July 2017, as follows:

Following the cancellation of the Repurchased Shares, the total number of ordinary shares with voting rights will be 393,657,354, which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Vertu Motors under the FCA's Disclosure Guidance and Transparency Rules. The Company holds no shares in treasury.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
